TAX INSPECTORATE

The requirement for application of V-login:

Please note that you must first have a username and password prior to submitting your application form for online filing. (Request an e-login online)

Clients must present themselves in person for validation.

- Individuals: Valid passport, ID card or driver's license,
 - A document in which the name and crib number of the person is stated (crib declaration, an assessment, etc.),
 - The crib number on the document must correspond with the crib number in the CRM system.

Company

- Chamber of Commerce Registration (not older than 6 months) in which the name of the (Managing) director is stated. The (Managing) director, has too identify him/herself as the legal representative of the company (valid passport, etc.)

Consultants -

- A consultant can be an individual or company and must be presented as such.
- Must first request an E-login;
- Must present statement of authorization. After validation of the statement of authorization the consultant may act on behalf of his/her clients.

Representative

- is a person that represents another but is not a consultant.
- Must present letter of representation including ID attached.
- Valid passport, ID card or driver's license (representative).
